## Summer Camp 2022 Payment Policies

**ACTIVITY FEE:** \$125 Activity Fee is charged for each camper regardless of the number of weeks enrolled. This charge helps defer the cost of special on campus entertainment programs.

**FIELD TRIPS/POOL:** As of now, field trips and pool trips are discouraged as a result of Covid19 regulations. We will, however, be having weekly on campus entertainers and sprinkler fun.

**REGISTRATION:** All application forms and fees, including \$125 activity fee, are due IN FULL by June 1st. \*\*\* Enrollment is limited and accepted on a first come, first served basis.

**FINAL SUMMER CAMP REGISTRATION DEADLINE - June 1, 2022:** All applications and fees must be submitted by June 1st. Applications received after this date will be placed on a waiting list and families will be notified if/when the requested schedule becomes available. \*\*\* Weekly rate will apply if you register after June 1st regardless of the number of weeks that your child will attend.

**Payment is due in FULL no later than June 1<sup>st</sup>.**

**EARLY BIRD PAYMENT SCHEDULE - PRIOR to April 1<sup>st</sup>:**

**Upon Registration:** First Installment of 25% of all camp fees due. **NON-REFUNDABLE.**

**May 2<sup>rd</sup>:** Second Installment of 25% of all camp fees due. **NON-REFUNDABLE.**

**June 1<sup>st</sup>:** Final Installment: Remainder of all camp fees must be paid in full.

**NOTE:** Failure to meet any of the above payment deadlines will forfeit the early bird rate and you will be charged at the regular rate. **THE EARLY BIRD RATE WILL EXPIRE ON APRIL 1<sup>st</sup> AND NOT BE HONORED WITH ANY SCHEDULE CHANGES MADE AFTER APRIL 1<sup>st</sup>.**

**REGULAR PAYMENT SCHEDULE - AFTER April 1<sup>st</sup>:**

**Upon Registration:** 50% of all camp fees are due. **NON-REFUNDABLE.**

**June 1<sup>st</sup>:** Remainder of all camp fees must be paid in full.

**CANCELLATION POLICY:**

**PRIOR to June 1<sup>st</sup>:** If final installment has been paid, 50% of total fees will be refunded.

If final installment was not paid, since 1<sup>st</sup> and 2<sup>nd</sup> installments are **NON-REFUNDABLE**,  
**NO MONIES WILL BE REFUNDED.**

**AFTER June 1<sup>st</sup>:** **NO REFUNDS WILL BE MADE.**

**ABSENCES:** No make-up days or refunds will be allowed.

**SCHEDULE CHANGES:** Any request for schedule changes will be considered based on availability and charged a \$50 processing fee. **Extra Hours:** (added to a scheduled day only) will be charged \$15 per hour.

**SCHEDULE REDUCTIONS:** Any schedule reductions made **PRIOR** to June 1<sup>st</sup> (including days, hours or programs) will result in a 50% refund of the difference in fees. Changes made after April 1<sup>st</sup> will forfeit any Early Bird Rates charged. Changes to your child's schedule will **NOT** be permitted for **any** reason **AFTER** June 1<sup>st</sup>.
