Summer Camp 2024 Payment Policies

ACTIVITY FEE: \$125 Activity Fee is charged for each camper regardless of the number of weeks enrolled. This charge helps defer the cost of special on campus entertainment programs.

FIELD TRIPS/POOL: Our Preschool and School Aged Campers have some field trip opportunities. Individual permission slips will be required and an additional fee will be charged to offset admission, lunch and transportation fees. THERE WILL BE NO OPT-OUT FOR THESE TRIPS so if you are not interested, do not sign up for the day.

POOL/SPRINKLER: Campers will have the option of taking part in sprinkler fun on our spacious playground or swimming at the Palisades Park Swim Club. This water fun will be twice a week and will be starting week 2 of camp. All campers going to the pool MUST be 3 years old and potty trained. See Pool Trip Form.

REGISTRATION: All application forms and fees, including \$125 activity fee, are due IN FULL by June 3rd. *** Enrollment is limited and accepted on a first come, first served basis.

FINAL SUMMER CAMP REGISTRATION DEADLINE - June 3, 2024: All applications and fees must be submitted by June 3rd. Applications received after this date will be placed on a waiting list and families will be notified if/when the requested schedule becomes available. *** Weekly rate will apply if you register after June 1st regardless of the number of weeks that your child will attend.

Payment is due in FULL no later than June 3rd.

EARLY BIRD PAYMENT SCHEDULE - PRIOR to April 1st:

Upon Registration: First Installment of 25% of all camp fees due. **NON-REFUNDABLE.**

May 1st: Second Installment of 25% of all camp fees due. **NON-REFUNDABLE.**

June 3rd: Final Installment: Remainder of all camp fees must be paid in full.

NOTE: Failure to meet any of the above payment deadlines will forfeit the early bird rate and you will be charged at the regular rate. **THE EARLY BIRD RATE WILL EXPIRE ON APRIL 1st AND NOT BE HONORED WITH ANY SCHEDULE CHANGES MADE AFTER APRIL 1st.**

REGULAR PAYMENT SCHEDULE - AFTER April 1st:

Upon Registration: 50% of all camp fees are due. **NON-REFUNDABLE.**

June 3rd: Remainder of all camp fees must be paid in full.

CANCELLATION POLICY:

PRIOR to June 3rd: If final installment has been paid, 50% of total fees will be refunded.

If final installment was not paid, since 1st and 2nd installments are **NON-REFUNDABLE**,
NO MONIES WILL BE REFUNDED.

AFTER June 3rd: **NO REFUNDS WILL BE MADE.**

ABSENCES: No make-up days or refunds will be allowed.

SCHEDULE CHANGES: Any request for schedule changes will be considered based on availability and charged a \$50 processing fee. **Extra Hours:** (added to a scheduled day only) will be charged \$15 per hour.

SCHEDULE REDUCTIONS: Any schedule reductions made **PRIOR** to June 3rd (including days, hours or programs) will result in a 50% refund of the difference in fees. Changes made after April 1st will forfeit any Early Bird Rates charged. Changes to your child's schedule will **NOT** be permitted for **any** reason **AFTER** June 3rd.
